To make the most of your time, we have outlined upcoming consultation activities so you can choose when, where and how you would like to have your say when it comes to changes that impact you, the sector you work within and the people you support.

## **Tasmanian Drug Strategy Final Consultation**

#### **Overview:**

The Department of Health, Tasmania, on behalf of the Tasmanian Government, is developing the new <u>Tasmanian Drug Strategy 2023-2028</u> (TDS). The TDS will provide a whole-of-government and whole-of-community framework designed to enhance the health, safety, and wellbeing of all Tasmanians. To date, a range of consultations have taken place, including with key stakeholders in 2021, and broad public consultation from May – July 2022 through an online community survey. Due to public interest, the Tasmanian Government will hold a final public consultation period from January – March 2023. This will consist of an online community survey via the Department of Health, Tasmania website and face-to-face community consultation workshops. Following this consultation period, the Strategy will be re-drafted for planned release in mid-2023.

## Reform Agenda for the AOD Treatment Sector 'Next Steps' Consultation

#### **Overview:**

In 2020, the Tasmanian Government released its 10-year plan for reforming the AOD treatment sector in Tasmania (the AOD Reform Agenda). Since this time, the Government has committed \$7.4 million over two years to commence five AOD Reform Agenda projects within the sector. the Department of Health, Tasmania, on behalf of the Tasmanian Government, wants to hear from participants within the AOD treatment sector to understand which of the remaining key actions will be taken forward into the 2023-24 Implementation Plan. The Department of Health, Tasmania will do this by speaking with sector representatives on two occasions: first in February 2023 and again in March 2023.

# Primary Health Tasmania's AOD Commissioning Consultation

#### **Overview:**

Primary Health Tasmania (Tasmanian Primary Health Network) is tasked by the Australian Government Department of Health with the planning and commissioning of federally funded AOD treatment services in Tasmania. Primary Health Tasmania currently commissions four organisations to deliver AOD initiatives across the State.

From December 2022, Primary Health Tasmania will undertake consultation with its commissioned AOD service providers and Aboriginal Controlled Community Health Organisations to inform the commissioning of federally funded AOD programs beyond 30 June 2023.
